Assessing the Impact of Rice Sector Policy Reforms on the Income Mobility of Rural Households in Nigeria

AGRODEP recently released its working paper. "Assessing the Impact of Rice Sector Policy Reforms on the Income Mobility of Rural Households in Nigeria" examines whether the policy reforms (specifically tariff barriers on imported rice and increased domestic rice production) enacted under Nigeria's Agricultural Transformation Agenda will lead to income benefits or losses for rural households. The author concludes that Nigeria's rice policies will lead to employment benefits and income gains for most households.
